Dear President Frederick:

At their July 2018 meeting, the directors of the National Architectural Accrediting Board (NAAB) reviewed the Visiting Team Report (VTR) for Howard University.

On behalf of the board, it gives me great pleasure to inform you that the **Bachelor of Architecture** degree program was granted an eight-year term of accreditation, with the stipulation that the Interim Progress Report (see below) addresses in detail the following "Not Met" Student Performance Criteria:

- B.10 Financial Considerations
- D.2 Project Management

The term is effective January 1, 2018, and the program is scheduled for its next visit for continuing accreditation in 2026.

In addition, the board reviewed the Addendum to the Substantive Change approved in July 2017 for a nomenclature change of its 5-year B. Arch. to an M. Arch. The board approved this Addendum, which provides transition plans for students who entered the Bachelor of Architecture program between August 2014 and August 2017. The transition plans are expected to be implemented as proposed in the Addendum.

Please be reminded that continuing accreditation is predicated on two reporting requirements:

- a) Annual Statistical Reports. These reports capture statistical information on the institution and the program. The next statistical report is due on or before November 30, 2018.
- b) Interim Progress Reports. Programs that receive an eight-year term of accreditation must submit an Interim Progress Report (IPR) two years after a visit and again five years after the visit. Howard University's first IPR is due November 30, 2020. There is more information on the IPR process in Section 10 of the 2015 *Procedures for Accreditation*.

Finally, public dissemination of both the Architecture Program Report and the VTR is a condition of accreditation. These documents must be made public electronically in their entirety. Please see Condition II.4.4 of the 2014 *Conditions for Accreditation* and Section 5 of the 2015 *Procedures for Accreditation*.
